General Conditions

Re E-tenders are invited for the supply of Sodhitha Gulgulu (Sudh Gulgulu) 2500 Kg.

1. Tender document should be uploaded through the website **www.etenders.kerala.gov.in**. Terms and conditions can also be downloaded from this website and cost of tender form mentioned should be remitted through online. Tenders received contrary to the above direction are liable to be rejected. The cost of tender forms once paid will not be refunded.
- 2 **Samples should be submitted to this office on or before 22.07.2017. Tenderers should quote their rate exclusive of GST.** The rate quoted should be inclusive of transportation at our Kuttanellur factory.
3. Intending tenderers should upload their tenders before the stipulated time on the due date and time. No tender received after the specified date and time will be accepted on any account. The rates will be considered firm for acceptance till the date mentioned below. Tenders not stipulating period of firmness and tenders with price variation clause and or subjected to prior sale condition are liable to be rejected.
4. The tenders will be opened on the appointed day and time in the office of the undersigned.
5. If any tenderer withdraws from his tender before the expiry of the period fixed for keeping the rates firm for acceptance, the earnest money, if any deposited by him will be forfeited to Pharmaceutical Corporation (Indian Medicines) Kerala Limited, Thrissur or such action taken against him as the Corporation thinks fit.
6. Time shall be the essence of the contract.
7. The final acceptance of the tenders rest entirely with the Pharmaceutical Corporation (Indian Medicines) Kerala Limited, Thrissur - who do not bind themselves to accept the lowest or any tender. But the tenderers on their part should be prepared to carry out such portion of the supplies included in their tenders may be allotted to them.
8. **Every tenderer should produce Address proof along with photo and signature to be attested by Gazetted Officer and copy of GST Registration Certificate issued by the commercial tax department attested by gazetted officer.**

9. Ordinarily payments will be made only after one month from the date of supply, the supplies are actually verified and taken to stock on production of proper bill signed by the contractor whether it is a part supply or not.
10. The tenderer shall undertake to supply materials according to the standard sample and/or specifications.
11. No representation for enhancement of rates once accepted will be considered.
12. The tenderer should submit along with his tender an agreement in the appended form duly executed and signed in stamp paper worth Rs. 200/-
13. All disputes, questions and claims arising out of or touching this agreement shall be subject to the exclusive jurisdiction of the courts at Thrissur only.
