GENERAL CONDITION

1. The quotation shall be submitted in the document purchased from the office or down loaded from the website
2. Last date of submission of quotation is 27.04.2017 , 3.00 pm and quotation will be opened on the same day 3.30 pm
3. No quotation will be accepted after the stipulated time and date
4. The cost of quotation document is Rs. 500/- + VAT. Those who down load document should remit the cost of document along the quotation.
5. The cover containing the quotation should be super scribed with words “**Setting up of Office cabins at sub-centre in Pathanapuram**”
6. The quotation should be submitted along with E.M.D of Rs.6250/- . EMD can be remitted in the form DD drawn in favour of Managing Director, Oushadhi payable at Thrissur or by cash. The EMD of unsuccessful quotationer will be returned without any interest after 30 days from the date of finalization of quotation.
7. The entire work should be completed within 45 days from the date of receipt of firm order.
8. An amount equal to 5% of the quoted amount of work should be remitted by the successful Quotationer towards the security deposit which will be released only after 12 months from the date of completion of work. E.M.D remitted along with the successful quotation can be adjusted against the security deposit. If the successful quotationer fails to remit the Security Deposit and execute an agreement in the prescribed format in stamp paper of required value within 7 days from the date of receipt of our letter of acceptance, the quotation is liable to be rejected and the E.M.D remitted should be confiscated.
9. The quotationer should have executed at least one civil construction job of value not less than 90% of the PAC in single contract during last year or current year as prime contractor or he must be a ‘C’ class contractor and should submit proof of the same along with the quotation. The quotationer shall have PF, ESI and other statutory registration.
10. The rate quoted should be inclusive of all taxes and it should be firm without any escalation till the orders is completely executed.
11. The payment in full will be released after 15 days from the date of submission of final bill after successful completion of the work
12. Time being the essence of the contract, the time of completion stipulated should be strictly adhered to.

If the quotationer fails to satisfactorily complete the work within the period stipulated in the quotation, Corporation may at their option either (1) recover from the quotationer liquidated damages at the rate of 1% of the contract value, for every week or part there of delay subject to a maximum of 10% of the total contract value. (2) cancel the order wholly or partially and complete it directly or reassign it to other agency at the risk and cost of the quotationer.
14. The quotationer shall visit the work site prior to the submission of the quotation if required.
15. Any clarification regarding the quotation can be had from the office of oushadhi during the working hours on all working days.
16. The quotation shall be kept open for a period of one month from the date of opening for acceptance.
17. Managing Director reserves unqualified right to accept or reject any or all quotations or invite fresh quotations or recheck any of the above conditions without assigning any reason whatsoever. The decision of the Managing Director will be final and binding on all.
