General Tender Terms & Conditions for e-Procurement

This tender is an e-Tender and is being published online for the Operation and Maintenance of 200 m₃/day capacity Effluent Treatment Plant at The Pharmaceutical Corporation (IM) Kerala Ltd. (Oushadhi) and 50KLD Effluent Treatment Plant at Oushadhi Panchakarma Hospital and Research Institute at Thrissur for one year. The tender is invited in 2 cover system from the registered and eligible firms through e-procurement portal of Government of Kerala (<u>https://www.etenders.kerala.gov.in</u>). Prospective bidders willing to participate in this tender shall necessarily register themselves with above mentioned e-procurement portal.

The tender timeline is available in the critical date section of this tender published in <u>www.etenders.kerala.gov.in</u>.

A). Online Bidder registration process:

Bidders should have a Class II or above Digital Signature Certificate (DSC) to be procured from any Registration Authorities (RA) under the Certifying Agency of India. Details of RAs will be available on <u>www.cca.gov.in</u>. Once, the DSC is obtained, bidders have to register on <u>www.etenders.kerala.gov.in</u> website for participating in this tender. Website registration is a one-time process without any registration fees. However, bidders have to procure DSC at their own cost.

B). Online Tender Process:

The tender process shall consist of the following stages:

- i. **Downloading of tender document**: Tender document will be available for free download on <u>www.etenders.kerala.gov.in</u>. However, tender document fees shall be payable at the time of bid submission as stipulated in this tender document.
- ii. **Pre-bid meeting**: NIL
- iii. **Publishing of Corrigendum**: All corrigenda shall be published on <u>www.etenders.kerala.gov.in</u> and shall not be available elsewhere.
- iv. **Bid submission**: Bidders have to submit their bids along with supporting documents to support their eligibility, as required in this tender document on <u>www.etenders.kerala.gov.in</u>. Manual submission of bids will not be accepted under any circumstances.
- v. Bids shortlisted by this process will be taken up for opening the financial bid.

1.0 NOTICE INVITING TENDER

1.01 Online tenders are invited by The Pharmaceutical Corporation (IM) KeralaLtd. 1.02 **QUALIFICATION CRITERIA**

The Contractors should have minimum 2 years experience in the operation and maintenance of sewage/effluent treatment plant of capacity not less than 140m3/day in a Government/ Quasi-Government/ reputed Private or Public Sector firms during the last seven years (2015-16, 2016-17, 2017-18, 2018-19, 2019-20, 2020-21 and 2021-2022). Attach certified copies of the Work Order and satisfactory completion certificates in respect of quality, time and satisfaction of client as documentary proof.

1.03 The tenderer should have Valid Registration Certificate, PAN, GST, ESI and PF registration.

Joint ventures and consortiums formed for the purpose of bidding are not eligible to quote for the tender.

- 1.04 Not more than one tender shall be submitted by a Contractor. More than one concern in which an individual is interested as Proprietor and/or Partner shall not submit tender against this notice. If anybody does so, all such tenders shall be liable to be rejected.
- 1.05 The information given is only indicative. The tenderers are required to visit the site and familiarise themselves with the site conditions, plant, etc., before quoting. The drawings, conditions of contract, schedule of quantities and the specifications may be carefully studied before they offer their prices. No claims for extra compensation over and above the quoted rates will be entertained by The Pharmaceutical Corporation (IM) Kerala Ltd. (Oushadhi) on the ground that the tenderer have misjudged site conditions, nature of substrata, tender conditions or any item of tender etc.
- 1.06 Contractors are advised to inspect and examine the plant and its surroundings and satisfy themselves before submitting their tenders. They themselves shall obtain all necessary information as to risks, contingencies and other circumstances, which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site and site conditions, whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed.

1.07 Submission of a tender by a Contractor/Agency implies that he has read this notice and all other documents and has made himself aware of the scope of work.

1.08 **EMD**

- .02 EMD of the unsuccessful bidder will be refunded without any interest on finalization of the Contract with the successful bidder.
- .03 EMD deposited with The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) will be forfeited,
 - i) if a bidder withdraws his bid during the period of validity specified
 - ii) if the successful bidder fails within the time limit to sign the Contract document
 - iii) fails to furnish the required Security Deposit.

1.09 **PERIOD OF VALIDITY**

The tender shall remain valid for acceptance for a period of 3 months from the date of opening of the tender.

- 1.10 In the case of item rate contract only rates quoted shall be considered. The rate thus quoted will deemed to include the cost of all fuel, power, all leads and lifts, taxes, levies, royalties all over heads, contingencies, profits, etc. and the quoted price is all inclusive. The total contract price shall also be worked out and entered in.
- 1.11 If the tender is made by an individual it shall be signed with his full name and his complete address. If it is made by partnership firm it shall be signed with the copartnership name by a member of the firm holding power of attorney to sign the tender who shall sign his own name and give the name and address of each partner of the firm and attach a copy of "Power of Attorney" with the tender authorising him to sign on behalf of the other partners. A certified copy of the "Registered Partnership Deed" shall also be submitted along with the tender. A certified copy of the registered deed shall also be submitted along with the tender. The tender should be in a sealed cover.
- 1.12 After the public opening of the tenders, the information relating to the examination, clarification, evaluation and comparison of tenders and recommendations concerning the award of contract shall not be disclosed to the tenderer and other persons not officially concerned with such process.

2.03.01 The main scope of work

The capacity of Effluent treatment plant is 200 m₃/day at Kuttanellur and 50KLD at Thrissur.

If The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) intimates the Contractor/Agency regarding misconduct, incapability, delay in discharging duties or non-performance of any personnel employed by the Contractor, he shall be removed from his duties in The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) and the Contractor/ Agency shall provide suitable substitutes immediately.

2.03.06 Assignment

The rights and obligations arising out of this agreement shall not be assigned or transferred to a third party without prior written consent of either party.

2.03.07 Duty Mobile Phone

Duty mobile phones shall be provided by the contractor at his own cost for the staff in ETP and pump house for all the 3 shifts.

2.04 CONTRACTOR'S PERSONNEL

2.04.01 The Contractor shall provide and employ personnel having skills and competences in their respective fields and as per The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi)'s requirements. The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) shall be at liberty to require the Contractors to remove forthwith from the site any person employed by the Contractor who in the opinion of The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi), misconducts himself or is incompetent or negligent in the proper performance of his duties or whose employment is otherwise considered by The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) to be undesirable and such persons shall be replaced by the Contractor without delay, with a competent substitute approved by The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi).

- 2.04.02 Contractor has to ensure always the required staff specified in the Special Conditions of Contract for operating the plant. If at any time the employees engaged is found to be less than that is prescribed in special conditions of contract, The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) has every right to recover the wages of the short supplied staffs at penal rates.
- 2.04.03 It shall be the duty and responsibility of the Contractor to comply with all statutory requirements with regard to the employment of his personnel. He shall be liable for payment of ESI, PF, insurance, labour welfare fund and all other payments as necessitated by the relevant statutes or otherwise. For all purposes the personnel deployed by the Contractor is his / her employee.

Contractors should comply with the provision of Contract Labour (Regulation and Abolition) Act of 1970, Contract Labours (Regulation and Abolition) Central Rules 1971 and Minimum wages & Rules thereof and other related labour laws of Central and State Governments. Contractor also required to observe all statutory and legal requirements of Central and State Governments and other agencies applicable to the work as well as any local regulations applying to the site.

The Contractors must submit copy of the labour license from district Labour Officer, if applicable (of The Pharmaceutical Corporation (IM) Kerala Ltd. (Oushadhi) jurisdiction) with 10 days from the date of issue of work order. The Contractors has to produce documentary evidence regarding ESI & PF registration and monthly remittance of ESI, EPF etc. as per prevailing rates of the Government on monthly basis or as and when asked for.

In case of non-payment of wages or any other dues to employees engaged by the contract, The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) reserved the right to make the payment and to recover the amount of such payment from the bill of the agency. From the second month"s bill onwards documentary evidence/receipt to the effect that EPF & ESI has been remitted to the concerned office shall submit along with the bill.

Sales tax or any other Tax on materials and also on the turn over, if any, in respect of this contract shall be payable by the Contractor and The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) will not entertain any claim whatsoever in this respect.

The Contractor should comply with all applicable laws, Ordinance, Rules & Regulations and prescribed in Contract Labour Act 1970, EPF Act 1952, ESI Act 1948, Payment of Wages Act 1948, Industrial dispute Act 1947 and Workmen Compensation Act 1923 as amended upto date, in respect of this contract and shall pay at his own cost all charges in connection there with.

2.04.04 All employees shall be of Indian Nationality and it will be Contractor's responsibility to give temporary and permanent address. Convicted or penalised persons shall not be employed.

2.04.05 The Contractor shall engage only the persons proposed in the manning details furnished in the tender for the works. In unavoidable circumstances and due to reasons beyond the control where the Contractor is unable to make available the service of a person proposed in the manning schedule he should apply to change the person with equal or more qualification and experience with the detailed biodata of the substitute proposed to The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) and get the approval before the substitution is made. Non observance of this stipulation will account to breach of contract and the Contractor will be responsible for the consequences thereof.

2.04.07 Immediately on entering into agreement the Contractor shall provide identity cards with passport size photograph for his staff. The identity cards should be worn by the Contractor and employees when they are within The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) premises. These identity cards should be returned to The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) as and when the services are terminated or the contract is concluded with The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) . Non return of identity card will attract a penalty of Rs. 500 per persons which shall be revoked from any payment due to the Contractor. For engaging casual labour for exigencies and such other works, their details are to be submitted to The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) and temporary passes obtained before they are allowed within the The Pharmaceutical Corporation (IM) Kerala Corporation (IM) Kerala Ltd.(Oushadhi) premises.

2.05 **INDUSTRIAL DISPUTE**

It is laid down that in case any industrial dispute has arisen or is apprehended between the Contractor and the employees/workmen, the Contractor is liable to see that the dispute is settled or to submit himself to legal proceedings rising out of such industrial disputes and The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) shall not be liable or responsible, in any manner, whatsoever, in this regard.

The Contractor has to ensure that the services are not distributed either due absenteeism or due to willful act of his staff. Maximum care and precautions shall be taken to avoid any system break down. In case workforce deployed by the Contractor resort to any kind of industrial action, the contractor shall arrange to deploy alternate work force of sufficient strength and competence to maintain the normal operations.

2.06 **PRESERVATION OF PEACE**

The Contractor shall take requisite precautions to prevent any riotous or unlawful behaviour by or amongst his workmen and/or others employed on the works by him, for the preservation of peace and protection of the inhabitants and security of property in the neighbourhood of the works.

2.07 **AGE LIMIT OF LABOUR**

The age limit foremployment of labourshall be in strict accordance with the existing labour legislation.

2.08 **ATTENDANCE REGISTER**

The Contractor shall maintain attendance registers and should make available at any time for verification by The Pharmaceutical Corporation (IM) Kerala Ltd. (Oushadhi) and should be maintained at places as decided by The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) of all those employed by him, on a daily and shift basis. The Contractor will be required to deploy his

personnel at ETP and its related premises on round the clock basis on all days including Sundays and holidays.

2.09 **SUB CONTRACTING**

Normally no subcontracting or assignment of work shall be allowed. However, in exceptional cases due to reasons beyond the control of the contractors, he may request The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) for subcontracting certain special work and The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) may consider such requests on merit. Such consent, if given, shall not relieve the Contractor from any liability or obligation under the contract and the contractor shall be liable for all the acts, defaults and neglects of the Sub Contractor, his agents, employees or workmen as full as they were the acts, defaults or neglects of the Contractor or his agents, servants or workmen. For enabling The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) to consider the request for sub-contracting part of the work as above, the Contractor shall furnish documentary evidence to the satisfaction of The Pharmaceutical Corporatio (IM Kerala Ltd.(Oushadhi) Sub Contractor that the possess qualification as per the contract requirement. But this will not be the sole consideration for The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) to decide whether to grant consent for sub-contracting work.

At any time of the Contract period the Contractor shall be responsible for the observance of the provisions of aforesaid clauses by the Sub Contractors employed by him in the execution of the contract.

2.10 **SPARES**

All the necessary spares for the maintenance are to be arranged by the contractor and the payment for the same will be made against actual bill.

2.11 TOOLS AND PLANTS

All necessary tools and plants required for the maintenance work are to be provided by the contractor at no extra cost.

2.12 CHANGE IN INSTALLATION

The contractor shall not make any change in the original installation of their specifications without prior approval of The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) or his authorised representative.

2.13 SAFETY REQUIREMENTS

The contractor has to take care of all the required safety procedures related to the work.

2.14 **COMPLETION OF TENURE**

On completion of the tenure of the agreement, if not renewed, the Contractor shall handover all the materials belongings to The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi)'s representative and the Contractor shall remove all materials belonging to him including the workforce without any delay. However, the Contractor shall continue to discharge their responsibilities till the next Contractor takes over the duty with same terms and conditions and the Contractor shall train the staff of the new Contractor.

2.15 FORCE MAJEURE

If performance by either party of its duties and obligation under this agreement is prevented or delayed by circumstances of force majeure including, but not limited to fire, flood, earthquakes, strike, war, riots, insurrection, any action undertaken or restriction imposed by authority of any Government agency of court, shortage of equipment or raw materials or any other act beyond its reasonable control, the time within which the affected party must perform shall be delayed for a period under such circumstances to a maximum of 120 days during which the parties shall use alternate methods, but after which period either party shall have the right to terminate the agreement. Determination of this agreement shall not relieve either party from the payment of the sum or performance of other duties and obligations, which may be owing to the other, as a result of the operation of this agreement prior to such termination.

2.16 **TERMINATION OF THE CONTRACT**

The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) reserve the right to terminate the contract at any time with one months notice if the performance of the Contractor is not satisfactory.

2.17 **JURISDICTION**

Any dispute connected with this contract shall fall within the jurisdiction of Courts at Thrissur.

3.0 INSTRUCTION FOR FILLING UP THE TENDER FORM

- 1. The tenderer has to pay earnest money deposit as specified in the tender notice along with the tender. Tenders for which earnest money deposit has not been received shall be rejected. There shall be no exemption for any tenderer from submitting the earnest money deposit.
- 2. Certified copies of Registration Certificate, PAN, GST, ESI & PF registration will have to be furnished for considering the acceptance of the tender.
- 3. The tenderer shall be responsible for furnishing the necessary forms/ returns related to GST.
- 4. The tenderer should return the original tender document after putting the signature on all pages.
- 5. The tenderer shall execute a preliminary agreement on non-judicial stamp paper of value not less than Rs.200/- and enclose the same with the tender documents.
- 6. The tender of the tenderer not complying with the above instructions may be rejected.

I/We have carefully read the above said instructions and shall comply with the same.

4.0 SPECIAL CONDITIONS OF CONTRACT

4.1 DETAILED SCOPE OF WORK AND SPECIFICATION

The contractor shall operate and maintain successfully and satisfactorily, the various systems of effluent treatment plant and related areas at The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) at Kuttanellur and Thrissur on round the clock basis on all days including Sundays and holidays for one year.

The Operation and Maintenance envisages all required tasks for

- 4.1.1. Regular Operation as per operating manual and keeping KSPCB standard and maintenance of effluent treatment plant, raw effluent pumping systems, treated water pumping system, etc. for one year.
- 4.1.2 Compliance to safety rules and regulations.
- 4.1.3 Periodical Maintenance

All the periodical / preventive maintenance of the effluent treatment plant and pumping stations including the electrical panels are to be carried out by the contractor.

4.1.4 Breakdown maintenance

The breakdown, if any for any of the components of the system are to be reported to The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) immediately. The contractor has to make arrangement for attending the breakdown/repairs as per the direction of the engineers of the The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) The cost incurred for the repairs of machinery by other agencies will be re-imbursed as per actuals on production of documentary proof.

The power charges shall be borne by The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi). Necessary chemicals like coagulant, lime, caustic, Poly Electrolyte, Activated carbon, etc., shall be arranged by The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi)

4.1.5 Chemical treatment:

The required chemicals for the treatment will be arranged by The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi). The chemical treatment is to be carried out as per the requirement to ensure proper treatment. Necessary stock register of chemicals to be used for treatment is to be maintained properly as per the instructions of The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi)

- 4.1.6 All day to day maintenance activities normally minor nature would be carried out such as :
 - a) Gland changing of pumps
 - b) Oil changing of gear boxes
 - c) Greasing of bearings
 - d) Changing of leaky gaskets in pipe flanges, etc.

Consumables required for the above shall be arranged by the contractor at his own cost.

- 4.1.7 Assistance for Liasoning with Kerala State Pollution Control Board.
- 4.1.8 Packing and storing of sludge in plastic gunny bags.
- 4.1.9 Unloading and stacking of chemicals and consumables in ETP.
- 4.1.10 Watering of plants in the garden.
- 4.1.11 The various units of Effluent Treatment Plant (ETP) are:
 - (a) Pumping systems at sumps
 - (b) Pretreatment system consisting of screen chambers, grit separators and oil traps of ETP.
 - (c) Equalisation tank with pumping system in ETP.
 - (d) Aerobic treatment system with aeration tank, diffusers, blowers, etc. in ETP.
 - (e) Secondary clarifier System in ETP.
 - (f) Chemical treatment system consisting of flash mixer, flocculator, chemical mixing tank etc. in ETP.
 - (g) Tertiary clarifier System in ETP.
 - (h) Filtration cum disinfection system consisting of pressure sand filter, activate carbon filter, pumps, hypochlorite dosing system in ETP.
 - (i) Treated water collection and pumping system in ETP.
 - (j) Sludge handling system consisting of filter press and pumping system in ETP.
 - (k) Blower, generator system, MCC panel, electrical equipment, etc. in ETP
 - (1) Others if any unless otherwise specified.
- 4.1.12 The primary aim of O&M operation is the running and maintenance of the Plant efficiently and economically, so that the treated water from the ETP meets the standards prescribed by Kerala State Pollution Control Board.
- 4.1.13 The basic requirements for the successful Operation and Maintenance of the ETP are:
 - i. A thorough knowledge of the process.
 - ii. A thorough knowledge of the Plant and equipment provided in the treatment plant and their functions.
 - iii. Assignment of specific maintenance responsibilities to operating staff.
 - iv. Good housekeeping.

- v. Proper and adequate tools.
- vi. Proper logging of all operation/maintenance activities.
- vii. Keeping stock registers, etc.
- viii. Observation of safety precautions and procedures.
- 4.1.14 The Plant operators should familiarise themselves thoroughly with each unit of the plant before handling the Plant units.
- 4.1.15 Opening or closing of necessary valves when pumping is commenced or stopped.
- 4.1.16 Taking samples of raw effluent and fully treated water, testing at reputed laboratory and recording of results in the register at required intervals.
- 4.1.17 Operating of all pumps and motors alternatively including standby ones.
- 4.1.18 Cleaning of various tanks in ETP once in a month, cleaning of plant premises, offices, blower room, DG room, etc. regularly on a daily basis and as and when required by The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi)
- 4.1.19 Backwashing of filters.
- 4.1.20 Recording the treated water quantity in the Plant using the electromagnetic flow meter and recording in register and forward monthly abstract to The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi).
- 4.1.21 Packing and storing of the sludge after dewatering in filter press in plastic gunny bags.
- 4.2 Prices

The total contract amount is inclusive all taxes, duties, levies, etc. No extra claims will be entertained in this regard.

- 4.3 General
 - a) Necessary penalty will be recovered as decided by The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) for the following.
 - i. In case of the disturbance of the operation of the plant/ pumping station due to the non-availability/ absence of the operating staff.
 - ii. For the malfunctioning of the plant due to the improper operation of the components of ETP/ pumping station.
 - iii. Unreasonably long breakdown of the system.
 - iv. Non-supervision by the supervisors as per requirement.
 - v. The treated water is not meeting the norms of Pollution Control Board.
 - b) TDS:-Taxes as applicable from time to time will be deducted from the payments.

c) Testing of samples:- The required samples of the treated water is to be tested monthly and test reports are to be submitted to The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi). The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) will test the treated water in an approved laboratory and if the results are not satisfactory suitable penalty shall be imposed on the Contractors.

The treated water generated from ETP should meet the standards prescribed by Pollution Control Board.

4.4 Staff pattern required for O & M to run the effluent treatment plant and related areas is as under (for 3 shifts of 24 hrs operation)

Necessary duty reserve, leave reserve, etc. also to be provided as per requirement.

4.5 WORK ORDER BOOK

All the registers and log books required for the O&M shall be provided by the Contractor. The contractor shall have to maintain the Maintenance registers, log books, Snag register, etc. at the plant showing therein quantity of chemicals, consumables and materials used per day for each unit of operation, break-down occurred and repairs completed, other details if any, etc.

4.6 PERIODICAL REPORTS

The weekly service reports of the ETP and connected system are to be submitted to The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi)regularly.

4.7 DAMAGES

In case of damages/ defects happened to the system due to the negligence or mistake of the serving personnel, the cost of repair is to be borne by the contractor.

4.8 GOVERNING OF LABOUR LAWS

The contractor shall be fully responsible for providing accommodation to all labourers employed by him under the prevalent rules of Central Govt., State Govt., or Local Body.

4.09 RATE OF O&M

The rate of O&M shall be inclusive of all taxes and duties for 12 months.

4.10 HANDLING OF CHEMICALS

Safety and facilities to the staff for handling of chemicals and equipment is an important consideration. Handling of chemicals needs special attention. Following instructions are for guidance of the contractor and observing them strictly at his cost.

Coagulant, Lime, etc.

For handling coagulant, lime and other chemicals, rubber apron, gloves and boots must be used and provided by the contractor to his staff at his cost.

4.11 TRANSPORTATION

Contractor will have to make his own arrangements like two wheelers for conveyance of his staff at his own cost. No facility will be provided by The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi).

4.12 MEDICAL

Contractor has to provide medical facility to his staff at his own cost.

4.13 CONTRACTOR'S STAFF AND THEIR CONDUCT ETC.

- 4.13.1 All employees shall be of Indian Nationality and it will be contractor"s responsibility to give temporary and permanent address. Convicted or penalised persons shall not be employed.
- 4.13.2. Regular salaries should be ensured to the staff as per minimum wages act. The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) will not take any liability in this respect. Contractor should submit monthly certificate for full payment to his staff on or before 10th day of every month.
- 4.13.3 Contractor shall arrange for substitute during any leave granted to the staff at his own cost.
- 4.13.4 The plant being a typical, visitors are expected to visit the plant, for which prior approval is to be taken from The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) It is expected that all staffs and supervisors be present and follow the directions of the The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) during the visits without any reservation.

4.13.5 Contractor will be solely responsible for all security issues related to his employees during O&M.

4.14 MAINTENANCE AND SUBMISSION OF RECORDS TO CLIENT

The contractor shall maintain various log books and records as per prescribed format of The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi) and submit the same once in a week. The details are as below:

- i) Quantity and hours of raw effluent pumping with log book.
- ii) Flow rate of efffluent
- iii) Sample collection and analysis report of raw effluent sample of ETP
- iv) Log Book of major operations
- v) Dosing of chemicals
- vi) Flow rate of sludge
- vii) Flow rate of Treated Water using electromagnetic flow meter.
- viii) Sample collection and analysis report of treated water sample of ETP
- ix) Electrical parameters/reading of various equipment
- x) Electricity consumption of various electrical equipment, details of running of DG set, blower, etc.
- xi) Maintaining daily upto date running of filter press.
- xii) Routine maintenance
- xiii) Breakdown maintenance
- xiv) Stock register of chemicals, consumables, nutrients etc.
- xv) Others if any as required or as directed by The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi)
- **4.15** After one year O&M the Contractor should hand over the plant to the Client with all electrical and mechanical equipments in good working condition.
- **4.16** The contractor should train next batch of operating staff nominated by The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi)for the smooth operation and maintenance of the plant before completing the one year O&M.

4.17 MAINTENANCE OF THE EQUIPMENTS

- 4.17.1 Daily maintenance schedule:
 - a) Motors
 - i. Checking bearing temperatures.
 - ii. Checking for any undue noise or vibration.
 - b) Panel, circuit breaker, starter, etc.

- i. Checking the phase indicating lamps.
- ii. Noting readings of voltage, current, frequency and others.
- iii. Checking the functioning of indication lamps.

4.18 PLANT MONITORING

- 4.18.1 The contractor shall maintain a record , for various parameters as indicated below:
 - i pH

Raw water Settled water Filtered water Final treated water

- ii pH paper required for shall be arranged by the Contractor at his own cost.
- 4.18.2 The contractor has also to arrange for analysis of treated water at the ETP from outside PCB approved laboratory once in a month. This sampling for analysis shall be monthly. The contractor shall have to bear the cost of taking samples, transporting to ETP to laboratory and get the same tested.
- 4.18.3 Daily on-off operation and routine cleaning of all light fixtures, ceiling fans, exhaust fans and allied fittings.
- 4.18.4 The cleaning materials such as brushes, brooms, dusters, washing solutions, detergent, phenol, air freshener, toilet soap, etc. shall be provided by contractor at his cost. All toilets and bathroom shall be kept clean, washed daily by using sanitary solutions and air fresheners at contractor's cost.

4.19 **DEPLOYMENT OF STAFF:**

- 4.19.1 The contractor shall provide two sets of uniform, one pair of gumboots, masks, gloves and one umbrella to each workman within two weeks from the date of start of operation and maintenance.
- 4.19.2 One laminated identity card with photograph attested by contractor shall be provided to each staff by the contractor after the approval of The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi)

4.20 OTHERS

- 4.20.1 Cleaning of equalisation tank, flash mixer, clarifiers, tanks, etc.
- 4.20.2 Algae removal from walls of equalisation tank, flash mixer, clarifiers as and when instructed by the Engineer of The Pharmaceutical Corporation (IM) Kerala Ltd.(Oushadhi)

5. PROFORMA OF PRELIMINARY AGREEMENT

If he fails to do this or fail to maintain a specified rate of progress, the security deposit shall be forfeited to Owner and fresh tenders shall be called for or the matter otherwise disposed. If as a result of such measures due to the default of the tender to pay the requisite deposit sign contracts to take possession of the work any loss to the Owner results, the same will be recovered from him as arrears of revenue but should it be a saving to Owner the original contractor shall have no claim whatever to the difference. Recoveries to this or any other account will be made from the sum that may be due to contractor on this or any other contracts or under the Revenue Recovery Act or otherwise as Owner may decide.

Now therefore these present witness and it is mutually agreed as follows:

- 1. The terms and condition for the said contract having been stipulated in the said tender form to which the contractor has agreed, a copy of which is appended, and which forms part of this agreement, it is agreed that the terms and conditions stipulated there in shall bind the parties to this agreement, except to the extent to which they are abrogated or altered by express terms and conditions herein, agreed to and in which respect the express provisions herein shall supercede those of the said tender form.

The decision taken by such authorised officer or officers shall be final and conclusive and shall be binding on the contractor.

The contractor further agrees that any amount found due to Owner under or by virtue of this agreement shall be recoverable from the Contractor from the Contractor from his EMD and his properties, movable and immovable as arrears of land revenue under the provision of the Revenue Recovery Act for the time being in force or in any other manner as Owner may deem fit in this regard.
