

## TERMS AND CONDITIONS FOR THE SUPPLY OF 1 No of UPS

### E-tenders invited for the supply Installation standardization and commissioning of 1 No of 20 kVA UPS

1. Tenders will be opened by authority concerned as per the schedule
2. Tender document should be uploaded through the website [WWW.etenders.kerala.gov.in](http://WWW.etenders.kerala.gov.in) Terms and conditions can also be downloaded from this website and cost of tender form mentioned should be remitted through online. Tenders received contrary to the above direction are liable to be rejected.
3. Rates should be **exclusive of GST and inclusive of all other expenses and for delivery of the items at our factory at kuttanellur, Thrissur.**
4. Each tenderer must remit an **Earnest Money Deposit 1% of quoted amount** through online.
5. Every tenderer should produce copy of Adhar card, Pan card, GST Certificate & Technical bid
6. The acceptance of tenders will be communicated to the tenderers in writing,
7. The Managing Director reserves to himself the right to reject the tender or to accept the tender.
8. The successful tenderer should provide warranty for 5 years from the Guarantee from the date of successful installation .
9. The successful tenderer shall, before signing the agreement and within the period specified in the letter of acceptance of this tender shall deposit a sum equivalent to **5 %** of the total value as security deposit and which will be refunded on successful completion of the guarantee period.
10. The tenderer should upload a preliminary agreement in the appended form duly executed and signed in stamp paper worth Rs.200/- and this should be submitted to the office along with the tender document.
11. The Managing Director will be at liberty to terminate the contract without assigning any reason either wholly or in part in one week's notice.
12. Payments will be made after **one month** from the date of successful installation subject to the execution of Agreement and remittance of Security Deposit..
13. The contract shall not be sublet without the permission of the Managing Director.
14. No articles shall be supplied to the corporation except on a requisition in writing signed by Managing Director or such other person authorized by the Managing Director in writing to do so.
15. The tenderer shall undertake to supply the item according to the standard sample and/or specifications.
16. No representation for enhancement of rates once accepted will be considered.
17. All disputes, questions and claims arising out of or touching this agreement shall be subject to the exclusive jurisdiction of the courts at Thrissur only.
18. The date upto which rates are to be firm for 30 days from the date of opening of the Tender.
19. The Successful Tenderer should supply and install at various points of the tendered item within 45 days from the date of awarding the Tender.
20. Liquidated damages @ 1% the of contract value per week for the delay of supply and installation subject to a Maximum of 10% of the total value of the contract.
21. The quote should be for supply, installation, commissioning and successful working demonstrations of the instrument at the premises of M/s. Oushadhi Ltd, Kuttanellur, Thrissur, Kerala
22. Specifications should be confirmed from the Technical Brochure and website of the manufacturer.
23. Goods Service and Technical support are essential. Please provide testimonials from three reputed customers.
